JOB DESCRIPTION

IREC seeks Interim Manager of Knowledge and Technology Transfer to fill the job for the duration of the selection process for its permanent appointment, in accordance with the regulations of the public sector. The professional will be responsible of technology transfer and business intelligence within the IREC's Corporate Development and Knowledge & Technology Transfer (KTT) team. In particular, tasks will include business intelligence (KPI's, evaluations and reporting, DDBBs); technology transfer activities, technology scouting and valorization strategies, negotiation and management of technology transfer contracts and agreements, and management of IREC's IP portfolio; promotion and coordination of competitive funding programs; project management and participation in sectorial committees and platforms.

This professional must be highly skilled in KTT activities, project management, business intelligence activities and must have a deep knowledge of energy related technologies and sector, including related competitive funding programs. Capacity to work in a team, flexible, service oriented with initiative and problem-solving skills would be valuable. High level of communication and negotiation skills are mandatory.

- PhD in Energy related fields (renewable energy, energy efficiency)
- Proven experience in KTT and Business Intelligence activities (at least 3 years)
- Knowledge and proven experience with IP evaluation and management tools

- Proven experience in research-industry collaboration projects and agreements, with special focus on technology transfer activities, programs.

- High proficiency in MS Office tools, especially Excel and Project, and ERP tools (SAP)
