IREC is looking for a Technology Transfer Officer. The professional will be integrated within the IREC's Corporate Development and Knowledge & Technology Transfer Department as part of the valorization and technology transfer team.

In particular, tasks include:

- Technology and exploitable results scouting. Identification and follow-up of research results generated at IREC's competitive projects.
- Valorization and exploitation strategies of identified research results, market prospection, elaboration of commercialization plans, support on business plan design, search of licensees, etc.
- IP protection and follow-up of the institution's IP portfolio.
- Support in the preparation and execution of tech transfer proposals and projects.

This professional must be highly skilled in technology transfer activities, project preparation and management and must have a deep knowledge of energy related technologies and sector, as well as of valorization strategies and public funding schemes. Capacity to work in a team, flexible, service oriented with initiative and problem-solving skills would be valuable. High level of communication and negotiation skills are mandatory.
